## Oxford Church, Phil<sup>a</sup> Feb. 9 '74

My Dear Sir,

Yr [sic] favor of Saturday, enclosing yr sic] check for \$23, my share of commissions on Mrs [sic] Johnston's Trust till this time, has just been rec<sup>d</sup> [sic]. Please accept my thanks for it.

You were right in supposing that I had rec<sup>d</sup> [sic] a communicat<sup>n</sup> [sic] from Mr [sic] Reed in reference to his resuming the work of writing the biography.
