Hereby declaring that the acquittances ~~and~~ receipts & orders of the said Laura and Clementina or either of them for the whole or any part of the said interest and dividends, or any other interest & dividends which may accrue on any loans or stocks hereafter purchased & held by e as their trustee during their joint lives and whilst both may remain single women shall be equally binding on me as if given by myself as their Trustee under their father[']s will.
