Scope and Content Note: The Hubley Collection contains legal documents, case papers, family and military papers, wills, deeds, bills and receipts, indentures for servants and slaves, correspondence, petitions, and church-related information.

Creators: Hubley family.

System of Arrangement: The legal papers are arranged chronologically. Case papers are arranged alphabetically by surname of the plaintiff or defendant. Family papers are grouped by the family member's name and chronologically within that name. Box 6 is arranged chronologically.
