Scope and Content Note: The Denues Family Papers contain documents related to the professional and military career of Charles Denues, as well as information about the Denues family. This collection also contains Civil War era items, including a \$20 South Carolina note, and a presidential ticket from the 1864 election.

Biographical and Historical Note: Charles Denues was born on 28 August 1923 in Shrewsbury Pennsylvania. He married Fannie Haines on 21 August 1859, and the couple had 8 children. Before enlisting to fight with the Union Army, Denues was a lawyer and a school teacher. In 1862 he enlisted, and became captain of the 135th Regiment, Pennsylvania Volunteers, Company E on 12 August 1862. On 24 May 1863 he was honorably discharged with the rest of his company.
