**Folder 1** Record book of Emanuel C. Reigart. The volume is labeled "Account Book." Record of the civil cases he worked on from 1822-1825, with notes about judgments or paperwork filed. In some cases, he has noted which client he represented and who represented the other. An index may be found at the back of the volume. 1822-1825. Note: Emanuel C. Reigart (1797-1869) was the grandson of Adam Reigart. He was admitted to the Bar in April 1822.

**Insert 1** Manuscript copy of specifications for an addition for the home of Emanuel C. Reigart at the northwest corner of Lime Street and Orange Street. The addition is to house an office, sitting room, dining room, pantry, bath room, basement, and three chambers. Document gives details for the demolition of part of the existing structure, excavation for basement, construction of the addition, new and existing building materials to be used, and plumbing, including a shower. Signed by E. C. Reigart and O. C. M. Caines. February 1853.

**Insert 2** Order for annuity payment to be made to his son, Henry M. Reigart. Order written by E. C. Reigart to John Reigart. 1 June 1863.

Manuscript copy of release of Emanuel Reigart by Daniel Oldenburgh upon the sale of real estate of Oldenburgh's late father, John H. Schwartz. September 1834.

Manuscript copy of a letter of attorney by E. C. Reigart, appointing his son-in-law, William P. Brinton, Power of Attorney. Witnessed by J. C and Annie Van Camp. 15 December 1862.

**Insert 3** Five accounts with William and John O'Brien, apparently dealing with the sale of property and a mortgage bond. 1862-1863.

Bounty tax, northeast ward. 1 April 1869.

State, county and school tax for the northeast and southeast wards. 14 June 1869.

State and county property tax. 17 June 1869.

City tax. 30 June 1869.

School tax. 31 July 1869.

School tax for Franklin property. 31 July 1869.

Federal tax on carriage, silver plate and a gold watch. 19 August 1869.

Envelope which contained the tax receipts. Henry E. Slaymaker, agent for Reigart's Old Wine Shop.
