<u>Scope and Content Note</u>: The Watt & Shand Collection contains materials related to the Watt & Shand Department Store in Lancaster, Pennsylvania. Series 1 includes employee handbooks, a job description, a beauty salon price list, bridal registry information, history of the store, a Christmas catalog, a Historic Preservation Trust calendar, and children's books. Series 2 is a record of the property at the downtown location and at Park City Mall beginning in 1880 with deeds, legal agreements, a building inspector's permit, blueprints, and insurance policies.

Biographical and Historical Note: On 22 February 1878, Peter Watt, James Shand and Gilbert Thompson advertised the opening of a new store, The New York Store, featuring new lines of foreign and domestic dry goods as well as fancy goods and notions. The New York Store opened on 9 March 1878 and was an immediate success focusing on customer service. The owners had an unwritten policy stating that they remained open until the last customer left. During that first year, partner Gilbert Thompson died. Watt and Shand purchased a building located at 8-10 East King Street and changed their name from The New York Store to Watt, Shand and Company. Then during 1885, the store name was shortened to Watt & Shand even though the business was expanding to acquire 6 East King Street. The Ladies' Ready-To-Wear Department was added in 1889 which included coats, suits, dresses, and underwear. The owners proceeded to expand the business over several decades and procured Appel & Weber jewelry store and Hager's Department Store during the 1950s and 1960s. The branch store opened in 1970 at Park City Mall. The Bon-Ton Stores purchased Watt & Shand in 1992 and the store officially closed in March of 1995.

Folder 2 Extinguishment of Ground Rent for Lot Number 126 on the South side of East King Street from Jacob M. Long, trustee to Gabriel Hirsh. Jacob M. Long was to receive \$200 for the extinguishment and would receive rent from Gabriel Hirsh which was set at forty-five shillings. Attached to the document is a note by Jacob M. Long to Gabriel Hirsh noting that Long had received Hirsh's payment. Signed 2 January 1880. In Record Book M, Volume 11, page 41, 31 March 1880.

Deed from Gabriel Hirsh and Bertha Hirsh to P.T. Watt and James Shand for their property on the South side of East King Street near Penn Square for \$22, 750. Signed 30 March 1885. Recorded in Deed Book I, Number 12, page 301 4, April 1885. Deed from George R. Reed, assignee of James Prangley to P.T. Watt and James Shand for their property on the South East corner of East King Street and Penn Square for \$35,000. Signed 3 April 1897. Recorded in Deed Book M, Number 15, page 105, 3 April 1897.

Folder 3 Extinguishment of Ground Rent for Lot Number 125 of the South side of East King Street from Jacob M. Long, trustee to Isaac Stirk. Jacob M. Long was to receive \$244.40 for the extinguishment and would receive rent from Isaac Stirk which was set at fifty-five shillings. Signed 19 March 1880. Recorded in Record Book O, Volume 11, page 604, 4 April 1881.

Deed from Isaac Stirk and Sarah C. Stirk to P.T. Watt and James Shand for their property on East King Street between Penn Square and Duke Street for \$24,500. Signed 25 March 1880. Recorded in Deed Book L, Number 11, page 288, 29 March 1880.

Folder 4 Deed from James Shand, P.T. Watt and Laura G. Watt, James Shand and P.T. Watt trading as Watt and Shand to Watt and Shand for the property on the Southeast corner of King Street and Penn Square for one dollar. Signed 18 March 1918. Deed from George R. Rohrer and Adelaide C. Rohrer to Watt and Shand for the properties at 24, 25, and 26 Penn Square for \$100,000. Signed 2 April 1920. Recorded in Deed Book I, Number 24, page 506, 2 April 1920.

Ground Rent Deed between the Lancaster Trust Company and Charles F. Rengier for the property of Lot Number 129 which is located on South Queen Street. Rengier was to be paid \$15.60 and Rengier was to pay a yearly ground rent of three shillings and six pence. Signed 27 March 1905. In Record Book W, Volume 17, page 186, 15 April 1905.

Folder 12 Deed from Fabian Yecker and wife to P.T. Watt and James Shand for the building on the east side of South Queen Street between Penn Square and Vine Street for \$18,000. Signed 1 April 1916. In Record Book P, Volume 22, page 381, 6 April 1916.

Folder 13 Building Inspector's Permit stating that the Watt and Shand store was to install a fire door between 17 and 19 South Queen Street. This cost was estimated by the building inspector to be \$1,000 and there was an inspector's fee of six dollars. 18 August 1967.

Insurance Title from Commonwealth Land Title Insurance Company from Alpheaus S. Groff and his wife to Watt and Shand for the building on 19 South Queen Street for \$150,000. Signed 24 February 1960. Recorded in Deed Book Y-48, page 419, 24 February 1960.

Receipt of Purchase for 19 South Queen Street from Alpheaus S. Groff and Ella L. Groff to Watt and Shand, Inc. for \$150,000. 24 February 1960.

Articles of Agreement between Alpheaus S. Groff and Ella L. Groff and Watt and Shand, Inc. for the property of 19 South Queen Street. Watt and Shand, Inc. were to pay the Groffs \$150,000 for their property and gave them the right to occupy the storeroom and basement of the building until 1 October 1960. Signed 5 February 1960.

Deed from Alpheaus S. Groff and Ella L. Groff to Watt and Shand, Inc. for the building on 19 South Queen Street between Penn Square and Vine Street for \$150,000. Signed 24 February 1960. Recorded in Deed Book Y, Volume 48, page 419, 24 February 1960.

Folder 14 Insurance Policy for 23, 24, and 25 South Queen Street between, Penn Square and vine Street. Watt and Shand purchased the insurance policy on these properties for \$80.25 and that any liability fees would not exceed \$16,050. Signed 30 March 1940.

Agreement between Arden P Reifsnyder, Christine K. Reifsnyder and Hager Realty Corporation. The agreement is to allow Hager to use land the falls under the Reifsnyder's property to be used for parking at 33-35 South Queen Street. Signed 28 April 1978.

Policy of Title Insurance for the property acquired by Hager Realty Corporation from Oblender's Furnishing, Inc. which was on 33-35 South Queen Street. The amount of insurance was set at \$28,200 for the property. Signed 19 December 1977.

Deed from Oblender's Furnishings, Inc. to Hager Realty Corporation for the building on 33-35 South Queen Street for \$28,200. Signed 19 December 1977. In Record Book U, Volume 72, page 560, 19 December 1977.

Electrical Certificate for the installment of five lights and a parking gate at the Watt and Shand parking lot on the South Queen Street side. The work was done by Kroll Electric Co. Inc. Attached is a note from Kroll stating what the certificate is for and the invoice number and process date. Certificate dated 22 November 1977. Invoice dated 28 November 1977.

Folder 17 Insurance policy for the change in property owners from John M. Ammon and wife to Watt and Shand for the building at 24 and 26 South Christian Street, between East King Street and Vine Street. Signed 30 June 1937.

Policy of Insurance purchased by Watt and Shand for the buildings at 24 and 26 South Christian Street. Watt and Shand purchased the insurance for \$50 and any liabilities could not exceed \$10,000. Signed 12 July 1937.

Deed from John M. Ammon and Cora M. Ammon to Watt and Shand for the buildings on 24 and 26 South Christian Street, between East King Street and Vine Street for \$10,000. Signed 12 July 1937. Recorded in Deed Book E, Volume 33, page 295, 12 July 1937.

Folder 18 Deed from R. S. Noonan and Ella Noonan and S. Edward Sherrill and Anita B. Sherrill to Watt and Shand for the building on 40 South Christian Street for \$16,500. Signed 30 November 1949. Recorded in Deed Book E, Volume 40, page 501, 1 December 1949.

Insurance Policy change for 40 South Christian Street when R. S. Noonan and S. Edward Sherrill sold the property to Watt and Shand by Commonwealth Title Company of Philadelphia. Attached to the front of the policy is a typed note of the property and the dimensions of whole property and an Objection titled Objection "F" stating a reason as to why Watt and Shand should not be able to own the property. Signed 1 November 1949.



Electrical Certificate from L. H. Rupert when they checked the electrical wiring in 40 South Christian Street, which was being used as Watt and Shand's Warehouse. 18 January 1968.

Watt and James Shand, trading as Watt and Shand for the property on Lot Number 130 on the western side of South Christian Street, between East King Street and East Vine Street, for one dollar. Watt and Shand were to pay the Pennsylvania Company for Insurance on Lives and Granting Annuities a yearly ground rent of seven shillings. Signed 17 July 1906.

Deed from P. E. Slaymaker to P. T. Watt and James, trading as Watt and Shand, for the property on the western side of South Christian Street, between East King Street and East Vine Street for \$15,000. Signed 20 July 1906. Recorded in Deed Book L, Number 18, page 119, 21 July 1906

Blueprint showing the survey of property at the rear of 33-35 South Queen Street. This survey and blueprint was done for J. Herbert Fehl. 7 November 1949.

Folder 20 Lease agreement between the Lancaster Parking Authority and Watt and Shand for the pedestrian overpass on the east side of South Christian Street. The lease started on 10 September 1986 and ended on 10 September 1987 and would automatically renew the lease annually. Signed 11 August 1986.

Folder 21 Letter from James Shand, President of Watt and Shand, to George B. Myrtetus, President of Total Energy Leasing Corporation, confirming that Total Energy will by modifying the HVAC system at the Watt and Shand store in Park City Shopping Center. The modifications would include the introduction 100% make-up air and a monitoring and controlling system to measure energy savings. This process cost a total of \$36,330. Dated 9 November 1979. Acknowledged by Total Energy Leasing Corporation 30 November 1979.

Letter from James Shand, President of Watt and Shand, to Lee Drukenbrod, Vice President of DUSCO Property Management. The letter is to confirm with the property manager of Park City Shopping Center that the Watt and Shand store in the shopping center would be undergoing modifications to the HVAC system. The new estimated cost on this letter is \$36,339. Dated 9 November 1979. Acknowledged by DUSCO Property Management, Inc. 15 November 1979.
