Geist's time at Millersville State Normal School, visiting cards, and newspaper clippings.

Defendants in case and relatives of Rush and Miller include Harry K. Geist, Daniel W. Geist, Lillian Dague, Lawrence Shirk, Richard Overly, Clara Witmer, Helen Wolfe, and Ruth Miller.
