Scope and Content Note: The Heleine Family Collection consists primarily of letters received by William B. Heleine and Rebecca Jane (Jacoby) Heleine during their youth and reflect the perennial concerns of that age group: friendship, courtship, and finding employment. Many of the letters are from William B. Heleine's cousin William F. Lebzelter, son of J. Philip Lebzelter founder of the Eagle Wheel and Bending Works (later P. Lebzelter & Son Co. then Lebzelter's) in Lancaster.

Folder 4, Insert 3 Receipts and Statements of Accounts of William B. Heleine Billhead of Jacob W. Fehl, Fine Groceries, Teas and Coffees, North Queen Street, Lancaster, Pennsylvania. An order for Myers and [Rath__] placed 28 May 1887 and a receipt for \$30.00 paid 18 June.

Billhead of Williamson & Foster, E. King Street, Lancaster, Pennsylvania. for a suit (\$16.00) and pair of suspenders (\$.25). A receipt for \$16.25 bought and paid 8 July 1887

Billhead of Williamson & Foster, E. King Street, Lancaster, Pennsylvania. for a stiff hat bought 16 September 1887. A receipt for \$2.40 (\$3.00 less 20%) paid 19 September. Billhead of Williamson & Foster, E. King Street, Lancaster, Pennsylvania. for buttons (\$.27) and binding (\$.6) bought 23 September 1887. A receipt for \$.27 (\$.33 less 20%) paid 24 September.

A handwritten statement from John Feagley, dated 2 July 1887 for \$.94 for merchandise to date.

Folder 4, Insert 4 Form Letter and Joke

Holiday form-letter to "Dear Sir" from F. A. Ferris & Co., Mott Street, New York. 1 January 1889. The letter expressed good wishes for the New Year and hopes that Ferris would be allowed to continue to serve them in the future. After the printed letterhead the two pages appear to be handwritten but may actually be printed. A handwritten telephone joke based on the phonetic similarity of "hello" and "hell."
