Folder 2, Insert 1 Land draft for Alexander Moore, now Joseph Smith and others, adjoining John Walker, John Mitchell, Jonathan Forsh, Howard Smith, Samuel Seiple, and Thomas Neel. Warrant, 3 May 1738. Surveyed 28 May 1739.

Land draft for land in Drumore Twp., known as the Forge Land and formerly owned by Bryan Quin. Adjoined by Jacob Gryder and Hugh Long. Surveyed by James Buchanan. 5 June 1807.

Land draft for Matthew Rippey for land in Drumore Twp., including a tract along Fishing Creek. Adjoined by John Ball, Brian Quin, Nathaniel Clark, John McIlray, and Robert Crawford. Surveyed by George Churchman. 25 June 1808.

Land draft for James Robinson for 140 acres on Fishing Creek in Drumore Twp. adjoining Matthew Rippey, Patrick [O'Starrow], Robert Crawford, John Ball, and John McElray. Surveyed by John Churchman. Certified by Samuel Ensminger. 21 July 1808.

Land draft for Matthew Rippey for land on Fishing Creek in Drumore Twp. adjoining Nathan Clerk, Bryan [Quin], and John Ball. Surveyed by John Churchman. Certified by Sam Ensminger. 21 July 1808.

Land draft for tract sold by Joseph Worrell adjoining Col. Hugh Long, Bolter, and Harra. Surveyed by Robert King. 12 September 1823.

Land draft for land in Drumore Twp. of Hugh Long once owned by the Forge and [John] Ball. Surveyed by Hugh Long. November 1826.

Deed between James and Martha McPherson and their son, James McPherson, Jr. for part of their land in Drumore Twp. 1 April 1807.

Deed between Joseph and Elizabeth Worrell and Elijah Worrell for land in Drumore Twp. 12 September 1823.

Folder 4, Insert 2 Mortgage between Samuel Boyd and Hugh Boyd of Drumore Twp. and Isabella R. Boyd, Ann Margaret Boyd, John S. Boyd, and Eliza R. Brown. Samuel Boyd and Hugh Boyd agree to pay Isabella Boyd, et al. for their Ioan. 6 May 1856.

Folder 5 Treasury Office Receipts and Promissory Note **Folder 5, Insert 1** The Treasury Office of Pennsylvania received payment from Hugh Long for land purchase in Drumore Twp. Signed by William Findlay, treasurer. 22 August 1809.

Treasury Office of Pennsylvania received payment from Patrick Harrah and Hugh Martin for patent fees for land in Drumore Twp. Signed by William Clark, treasurer. 5 April 1825.

Folder 5, Insert 2 Promissory note from the Bank of the United States to [G. W. Fairman] for \$1,000. No. 8894. 15 December 1840.



Folder 6 Agreements and Indentures

Conveyance (indenture) between George Gill and David Crawford for land in Drumore Twp. 18 March 1767.

An Orphans' Court order for confirmation of the value of the real estate of Thomas Porter. The court's decision reads that his land cannot be divided between his widow and children. 26 March 1784.

Article of agreement between John James and Robert H. Long, both of Drumore Twp., and Jacob Yost of Bucks County. Describes details for payment of the execution of the estate of Hugh Long. 24 December 1833.

Article of agreement between James Long and Robert H. Long of Drumore Twp. and Elijah Worrell of Drumore Twp. for the sale of land by Worrell to James Long and Robert Long. 24 October 1838.

Article of agreement between Henry W. Pennepacker and Elijah Worrell concerning land boundaries. 27 June 1842.

Bond between Elijah Worrell and Edward Crawford, both of Drumore Twp., and Valentine Gardner of Martic Twp. 1 April 1850.

Folder 7 Receipts, Invoices, Account

Account of debts against the estate of R. H. Long. List of debts for hardware, printing, cigars, and Thaddeus Stevens. No date.

Account of Mr. Hammelton, possibly from William White. Account lists table, chairs, hose, jars, and cupboard. No date.

Rily Warner of [Lock Haven] received payment from James Long and Cornelius Collins for the funeral services of R. H. Long. 29 October 1866.

Invoice from Kintzing & Co. to the estate of R. H. Long for water crackers. 5 November 1866.

William White of Lock Haven received payment from James Long. 18 January 1867.

Frank Heckert received payment from James Long for meals and horse feed while attending to the business of the estate of R. H. Long. 11 February 1867.

Letter from Robert H. Long in Lancaster to Mr. John Calvert. Letter requests more information about a bill that is to be paid. 28 March 1866.

Letter from Cornelius Collins of Lancaster to James Long. Letter discusses the collection of money. 8 November 1866.

Letter from H. E. Slaymaker in Lancaster to Samuel Long. Letter discusses a bill against the estate of Robert Long. 30 November 1866.

Letter from C. Widmyer of Lancaster to James Long requesting payment on a bill for the estate of Robert H. Long. 8 December 1866.

Letter from Altick & [McGinnis] in Lancaster to Mr. Long addressing a bill that is being sent to the estate of R. H. Long. 6 February 1867.
