A will of Amelia F. Lyte signed 1916 assigning her daughter Mary Rebecca Lyte (nurse) the house on 111 N. Lime St. Lancaster, PA and its contents, to her son Harold Lyte a legacy from his grandmother Fleetwood and other monies, witnesses William H. Keller and Mabel Mae Kline, 1919 with a 1921 addendum to the will
