<u>Biographical and Historical Note</u>: Daniel S. Geist was born June 27, 1813 and lived in Blue Ball, East Earl Township. He served as a Justice of the Peace for 15 years and as Mercantile Appraister for the year 1856. He married Sarah Oberline and had three children. He died 9 March 1901 and is buried in New Holland, Lancaster County.

Each category is broken down by township or borough and records the class of licenses paid by the various vendors. The verso of page 1 reads: "To vendors of Merchandize in Lancaster County with the classification of the same, agreeably to the provisions of the several acts of Assembly. The amount of license required to be paid by each class is as follows..." and records each class of license and its fee. Additional information about Daniel S. Geist is also included.
