Insert 1 Bond for money owed to Benjamin Good from Daniel Sterneman of Conestoga Twp., 23 March 1845. Witness: Jacob Shanck.

Insert 2 Bond for money owed to Christian Sterneman Sr. from David Sterneman of Conestoga Twp., 5 February 1865.

Insert 3 Copy of the will of Jacob Sterneman, Washington Twp., Franklin County, Pennsylvania, 17 October 1842. Also mentions: son Abraham Sterneman; daughter Mary Stouffer married to Christian Stouffer; daughter Anna; wife Mary Sterneman; Christian Good, executor; witnesses, John Nell and Daniel Tittle; William Mason, Deputy Register; John W. Reges, Register.

Folder 2 Records of Henry Dougherty

Insert 1 Postal card sent from Franklin Sutton, Lancaster, Pa., to Henry Daugherty, Bainbridge, Pa. Written on back: "Lancaster, Feb. [?], Dear Sir, Your kind favor is at hand and will say that in two weeks it will do. Yours Truly, Franklin Sutton"

Insert 2 Subscription voucher for the Lancaster New Era for the term 7 June 1886 to 17 June 1887, cost \$2.00. Paid by Henry Dougherty on 12 March 1886 to H. M. K. Erisman.

Insert 3 Bill of sale for items of furniture purchased by Henry Dougherty from Samuel F. Frey of Marietta, 28 February 1887. Items possibly purchased for Dougherty's son-in-law, Albert E. Miller. Document is torn, left corner missing.

Insert 4 Bill of sale for household items and hardware purchased from Sterrett & Spengler of Marietta by Henry Dougherty, 12 April 1887.

Folder 3 John and Anna Dougherty Letters

Insert 1 Letter possibly from Anna Ebersole to Anna Dougherty. Written from Sterling, Whiteside County, Illinois, 2 July 1869. Other names mentioned: Jacob Martin, Aaron Dougherty, Christian Ebersole, John Burgholder.

Insert 2 Letter to Aaron Dougherty from John Dougherty, Sebastopol, Sonoma County, California, 20 May 1880. Mentions "Bro. Ben" moving to Tombstone, Arizona.

Insert 3 Letter written by John Dougherty from Rough & Ready, Nevada County, California, to his brother (unidentified), 15 April 1853. Describes working conditions and weather in mining country in California.

Insert 1 Bill of sale for M. A. Miller for \$19.80 for carpet from J. W. Dibeler, Maytown, 2 April 1887.

Insert 2 Letter from Abner Miller to unidentified person, Rock Hill, 26 March 1877. Mentions Mary Myers, Henry Dobler, Casper Hiller, Will Haberstick, Henry Herr.

Folder 5 Graybill Family Items

Insert 1 Letter from M. Graybill of Leitersburg, Maryland, 15 July 1866, to a nephew in Lancaster County. M. Graybill is likely Michael Graybill (b. 1782, d. 1875 in Washington County, Maryland) who was a distiller. He mentions crop predictions and distilling, as well as Ephraim, who may be his son Ephraim Graybill.

Insert 2 Letter to Mr. Michael Graybill, Maytown, from James McClintock, attorney, of Chambersburg, Pa., regarding payment from Franklin County Bank and Union Banking Co. of Philadelphia, possibly to do with a court case in which Mr. Graybill was plaintiff.

Insert 1 Instructions for preparing "Drying Oils" written by Barb H. Hostetter, 1824. "To prepare for Carriage, Wagon, and Floor Painting..."

Insert 2 Bill of sale for goods purchased from W. S. Smith, dealer in general merchandise, Bainbridge, Pa., 5 June 1888. Written on back: "Received payment, W. S. Smith, per Wm. Schwan, July 10, 1888".

Folder 7 Will of John Krebill, 1812. Recorded in Lancaster County Will Book L, Volume 1, Page 134 as John Grebill. *Transferred from Document Collection, Box 27, Folder 1, Item 1, 17 February 2022.*

Also mentioned: wife, Maria Rohrer; son Abraham Rohrer; Jacob Bear; Henry Schenck; Jacob Stoner; son John Rohrer; Jacob Haberstick; John Schenck; Adam Brenneman; son Henry Rohrer; son David Rohrer; son Christian Rohrer; daughter Mary Herr, wife of Emanuel Herr; [Elizabeth] wife of [____] Gochenauer; son Jacob Rohrer; David Burgholder; witnesses Christian Schenck and John Herr; John Whiteside, Register. *Transferred from Document Collection, Box 27, Folder 1, Item 15, 18 February 2022.*

Folder 13 Appeal of Letters Testamentary of the estate of Christian Rohrer of Conestoga Twp., 10 January 1838. Folder 14 Order to Supervisors to vacate a part of the road from Martick Forge to Wright's Ferry (now Columbia) at or near Sterneman's kiln, and to lay out another in lieu thereof in Conestoga Twp., filed in Quarter Sessions Court, January 1848. Mentions Conestoga Centre and Harnish's Mill. Also mentions Daniel Sterneman. Road viewers: Andrew Mehaffey, Abraham Haverstick, Isaac Heiney, Godlib Sener, John Warfel, and Abraham Mylin. *Transferred from Document Collection, Box 27, Folder 1, Item 9, 18 February 2022.*
