of *two Hundred & fifty pounds* Lawfull Money of the s<sup>d</sup>. Province to be paid to  
the Said Peter Evans or his Certain Attorney Executors Administrators or Assigns to  
which payment well and truly to be made we Bind our selves our heirs Executors & Adminis-  
trators Joynly & severally firmly by these presents Sealed with our Seals & Dated this  
*second Day of February* In the Year of our Lord 1742

The Condition of this Obligation is Such that if the above bound *Valentine*  
*Stouwer* Administrator of all & singular the Goods Chattels of *Valentine*  
*Stouwer* Deceased Do make or cause to be Made a true & perfect Inventory of all  
& singular the Goods Chattels & Credits of the s<sup>d</sup>. Deceased which have or Shall Come  
to the hands possession or Knowledge of the s<sup>d</sup>. *Valentine* — or into the hands or poss-  
ession of any other person or persons for him and the same so made do Exhibit or Cause to be  
Exhibited into the Registers Office at Lancaster on or before the *second Day of March*  
—— next & the same Goods Chattels & Credits of the s<sup>d</sup>. Deceased at the time of
