or unto the Hands or Possession of any other Person or Persons for *him* and the same so made, *Doth* exhibit in the Register's Office at Lancaster at or before the *fourteenth*

Day of *August* next ensuing, and the same Goods, Chattels and Credits *Doth* well and truly administer, according to Law,
