IMIRCDUCTCRY NOTE

The microfilm of which this rall constitutes a part reproduces original tax records now in the custody of the Lanosster County Historicel Sooiety. Totaling sixty-eight boxes and seven voluses, these records mere crested during the assessment and oollection of taxse in the political subdivisions of that county. They were transferred to the historioal sooiety by the Lancester County Comisisioners in 1961.

The bulk of these records, amounting to sixty-seven boxes and dating from the period 1750-1855, are of the following subdivisions (tomnshipe unless othernise identified) which remain today in Lancaster County:

The remaining records, comprising one box and seven volunes, are of tomahips which were formerly in Lancaster County but are todny in Dauphin and/or Lobenon countios (erected in 1785 and. 1823, respectively). These particular recorda date froa a shorter period: that of 1750-1788. The tommbilpe to which they pertain, and the counties in which these tomahips are now locatod, are as follows:
