The Old Welsh Graveyard Revisited

The earliest grave on record in the Welsh cemetery in what is now East Earl Township, Lancaster County, Pennsylvania, is that of Thomas Morgan, who died intestate in 1733. In a statement by Thomas Edwards dated October 18, 1738¹, "About seven years ago (Rees) Morgan's father died and left a widow and seven children... his father and several others of the deceased of the neighborhood had been buried on ye vacancy...joining his mother's place and Jenkin Jenkin's lands."

Thomas Edwards had received from the "Hon^{ble} Proprietor" through Secretary Peters a copy of Jenkin Jenkin's petition concerning 350 acres, which were claimed by both Rees Morgan and Jenkin Jenkins. The source of an earlier dispute between Jenkin David and his son-in-law, Rees David, the improvement on the 350 acres was sold by Rees David, passing through William Davies and Nathan Evans to Thomas James, and then the Jenkin Jenkins, who lived in Chester County. Rees Morgan, the son-in-law of Thomas Edwards, had settled next to the disputed 350 acres, which contained the grave-yard. Thomas Edwards apparently mediated the settlement, as he says "Upon the whole, Rees Morgan and Jenkin Jenkins divisions as they stand now are pretty well accomodated with convenience for each settlement." On December 12, 1738, Jenkin Jenkins was isued a patent for the 357 acres, and on October 12, 1742, Rees Morgan



patented the 215 acres next to it,² including, it was thought, the cemetery. A remeasurement in 1764 showed a new patent was necessary for the 125 perches of the cemetery, and it was issued on November 14, 1764.³ (See figure 1)

B.F. Owens visited the cemetery in 1896, recorded the inscriptions, and wrote an article entitled "The Old Welsh Graveyard". It was published in the first volume of *Historical Papers and Addresses of the Lancaster County Historical Society* in 1897. He had as much trouble as everyone else with all those Welsh names and confused Jenkin Jenkins, a rich absentee owner, with Jenkin David or Davies, who settled on 1000 acres near Hinkletown, Earl Township. Owens was also apparently confused about the two Thomas Edwards of early Pennsylvania. He assumed that the Quaker son of Alexander Edwards was the one who came to Lancaster County.⁴ It seems more probable that the Thomas Edwards of Easttown Township, Chester County, who was prominent in the affairs of St. David's Episcopal Church in Radnor between 1717 and 1721, was the one who became one of the first justices of Lancaster County when it was formed in 1729.

This Thomas Edwards purchased 500 acres in Easttown Township now in Delaware County, on March 23, 1714, and he and his wife, Elizabeth, sold 100 acres of it on March 6, 1715, and 386 more of it on May 11, 1724 to Anthony Wayne.⁵ He appeared and acknowledged his signature on August 13, 1759, the "Tho: Edwards" that appears on so many Lancaster County papers of the period. His daughter, Ann Edwards, was married about 1717 to Evan Harry, the elder, and 120 acres in Merion Township were conveyed in trust to Thomas Edwards of Easttown Township and William Davies of Radnor Township for a life estate to Evans and Ann Harry, with provision that "in case the sd Evan and Ann should happen to leave but one child", then half of the land should go to the said child when of age.⁶

Thomas Edwards was one of the twelve Commissioners selected to run the line separating the new county of Lancaster from Chester. In the organization of the county he was made one of the eight justices, his first commission being dated May 8, 1729. The county was divided into eight districts, and Thomas Edwards was allotted Robeson, Caernarvon, Cocalico, and Earl Townships. He continued as justice for eight terms, until 1757, and was presiding Justice from 1741 to the November session, 1757. He was elected eight times to the Colonial Assembly, in the years 1729, 1730, 1731, 1732, 1733, 1735, 1736, and 1739, serving at the latter date when 66 years old.⁷ He was 84 when he retired as justice in 1757, and died on May 8, 1764 aged 91 years, according to the gravestone on lot 23 of the Welsh Cemetery. His wife, Elizabeth, had died on November 30, 1754 "in the 76th year of her age", according to her gravestone on lot 24. (See figure 2)

In April, 1768, Joseph Williamson was employed to enclose the ground of the cemetery with a stone wall two feet thick and three and a half feet high on the inside, the enclosure being $75\frac{1}{2}$ by $82\frac{1}{2}$ feet. The bill of Joseph Williamson for the labor was 17 pounds, 18 shillings and 4 pence. Eighteen pounds of nails were used to secure the covering. This and the other material used were paid as separate items by Rees Morgan. His daughter, Bettie, aged 24 years and single, made several trips for nails, as the work progressed, to the store at "the Blue Ball"⁸

Rees Morgan died less than a year later, on January 13, 1769, aged 59, and is buried in lot 21 beside his wife, Margaret nee Edwards, who died August 20, 1781, aged 76 years. His will was proved at Lancaster on February 9, 1769 and said "I give to my wife Margaret and my said son David that Piece of Land where the Grave Yard is situate in Earl Township containing 125 perches to be held and possessed by them and their Heirs forever. In Trust nevertheless that the said Grave Yard shall be for the use of all such as shall desire to burry their Dead there at all times and I do enjoin them my said Wife and Son to let what remains unfenced of the said Piece of land to such person as will rent or lease the same and the money it will rent for I allow to go to pay the quit rents for said Piece of Land and what remains towards keeping the fence about the Grave Yard in repair."

Elizabeth Morgan married John Pawling on September 9, 1771 and died on March 4, 1786, buried in lot 20. At an Orphans Court in Lancaster on December 17, 1788, Henry Pawling of Montgomery County, Pennsylvania was appointed guardian of his grandchildren: Henry Pawling, above 14 years, and Margaret, Eleanor, Elizabeth, and Rachel Pawling, all under 14 years. These were the only heirs of Rees Morgan, as his two sons had died single.

When Thomas Morgan died in 1733, his widow, Gwen, a weaver by trade, was left with seven children, "some of them not able to get their living", according to Thomas Edwards. On August 14, 1740, she purchased a lot in what became the city of Lancaster on the northwest corner of Orange and Water Streets.⁹ In her will dated August 11, 1746 and proved on September 26, 1746, she names her four sons and three daughters, as well as three of her grandchildren. Eldest son Morgan Morgan, his son Nathaniel Morgan, daughter Ann, wife of Edward Thornbrough, and her son Thomas Thornbrough.

divided the city property. Her son, William, was bequeathed five pounds, but "if he does not Return to Pensilvania in Seven years from the date of this will' it was to be paid to "my granddaughter Gwen Perry". When some of this property was sold in 1764, Edward Thornbrough, his wife Ann, and his son, Thomas Thornbrough, were living in New Marlbrough, Rowan County, North Carolina.¹⁰ According to a family source¹¹, Nathaniel Morgan, a descendant of Gwen Morgan, bought land in Cumberland County, Kentucky, in 1801.

Two of her daughters were named as Joan Davis and Elizabeth Davis. Joan Morgan was married about 1731 to Zaccheus Davis, the youngest son of Jenkin Davies. It is believed that Elizabeth Morgan is the Elizabeth who was married about 1730 to John Davis, the elder, who died in 1772.

A Jenkin David owned land in the uppermost part of Uwchlan Township, Chester County, well before 1715 and was probably related to the John and Thomas David who owned adjoining land.¹² Jenkin Davies, apparently his son, acquired 197 acres in Radnor Township and occupied the property from 1719 through 1727, according to assessment records.¹³ The will of the elder Jenkin David was dated August 9, 1727, and proved April 16, 1728 in Chester County, with "my brother-in-law Evans and Thomas Edwards as agents and guardians and assistants to my said beloved wife Martha, the sole exequtrix". It was apparently about this time that Jenkin Davies came to Earl Township, Lancaster County, to live, although he had had 1000 acres plus allowances surveyed to him on October 12, 1720 on a warrant dated June 18, 1720. A resurvey on September 30, 1740 resulted in a new patent.¹⁴

Jenkin Davies wrote his will on February 12, 1747 and it was proved by Rees Morgan and Thomas Edwards, two of the witnesses, on December 5, 1748. (See figure 3) There is no gravestone to mark his grave, but it may be one of the fieldstones in the Welsh cemetery that has no markings.

His Welsh Bible, printed in London in 1677 and 1678,¹⁵ records the dates and moon ages of his seven children. (See figure 4) Jaen Davies was born "1702 January 14 Wednesday evening", and is probably the one whose sandstone grave marker has been read as John or Joan Davis, and the death date as January 21, 1738, aged 56 (36?) years.

Zaccheus Davis, the most well known son of Jenkin Davies, was born February 21, 1710 and died March 25, 1788. He is buried in lot 35 beside his wife, Joanna nee Morgan. He succeeded Thomas Edwards as a justice of the court in 1757 and remained in that position for 31 years. Elected on December 15, 1774 a member of the Committee of Observation for Lancaster County, he served as a 2nd Lieutenant in the Chester County Militia 1777-1778. Only one of his nine children is buried in the Welsh cemetery. Zaccheus, Jr., a millwright, was born 1757, died July 4, 1793 without issue, and is buried in the Welsh cemetery in lot 31. His will, dated April 25, 1793 and proved on June 2, 1793, is a genealogist's delight, as he names most of his relations. The family outlines included at the end of this article were built on records such as this, combined with family records.

The eldest child of Jenkin Davies, Catharine, was married to Rees Davis when her father's will was written in 1747. She was to inherit five pounds "if she outlive her husband". Apparently the rift which started in 1720 over the 350 acres never healed. Since no wife is mentioned in the will of Rees Davis dated November 19, 1751 and proved February 7, 1753, she probably never lived to enjoy her five

pounds. She and her sister, Sarah, the wife of John Edwards, each received one shilling from the executors, their mother, Mary, and brother, John. This seems a bit miserly, since each of the three sons inherited 400 acres. The eldest son, Evan, went to live on the Radnor plantation which was part of his inheritance.


Jenkin Davies retained his plantation called Esgerwen¹⁶ in the parish of Cilcennin, Cardiganshire, Wales, and provided an elaborate succession of heirs in his will to insure 'that the said land be not sold forever out of my blood''. (See figure 5) The farm is now owned by a retired engineer from Kent, England, but descendants of Jenkin's brother, Evan, who returned to Wales before 1747, live nearby. One of them was born on Esgerwen before ''it was sold out of my blood''. The present owners still pay 10 shillings a year to a descendant, based on a strange legal quirk dating back to the last century.

John Davis, the middle son, died on March 21, 1774 and is buried in lot 33 beside his wife, Elizabeth nee Anderson, who died December 19, 1798. His oldest daughter, Sarah, single when her mother's will

was written in 1792, was to share with her brother, Isaac, half of her mother's books, including "the five Volums of Mr. Henry's Works".

His eldest son, Richard Davis, went to New Market, Frederick County, Maryland, about 1790 with his wife Catharine nee Hinkle and seven children. He was killed on December 17, 1791 when a barrel of molasses fell on him. His widow then married Jesse Wright.

Martha, also called Margaret, was the third child of John Davis. She married in 1768 Robert Wallace, who died December 7, 1793 and is buried in lot 30. Isaac Davis, John's youngest child, was one of the earliest Methodists in Earl Township and was ordained a minister in 1803, a calling he pursued until his death on January 5, 1838.¹⁷ He and his wife, Lydia nee Carter, are buried in lots 5 and 6.

Sarah Davis, the eldest daughter of Isaac and Lydia Carter Davis, was married on March 3, 1803 at the age of 21 to Henry Hambright, Junior, about the same age. He enlisted at the age of 33 in the U.S. Army in the War of 1812 and "was slain by the Enemy or did otherwise die in the Service of the U.S." at Fort Buffalo, New York, leaving three minor children.¹⁸ Sarah died September 4, 1867, aged 85 years, 9 months and 5 days, and is buried in lot 19.

The father, mother, and step-mother of Henry Hambright, Junior, are also buried in the Welsh cemetery. Henry Hambright, Senior, was the son of John Hambright, the German veteran Indian fighter who died in 1782, and his wife, Elizabeth. He was married on July 29, 1777 in St. James Episcopal Church, Lancaster, to Mary Good, daughter of William Good, who owned land near the Morgans in Earl Township. She was born in 1753 and Died August 4, 1825. Subsequently, Henry Hambright married a Mary Ann, who outlived him by only six weeks, dying April 12, 1835.¹⁹

The military career of Henry Hambright, Senior, began as a private under Captain David Morgan (H42) on June 1, 1776. He was taken prisoner at the Battle of Germantown. A major in the Pennsylvania Militia from 1785 to 1792, he rose to Brigadier General in 1800. He was a member of the Pennsylvania legislature in 1813, 1814, 1816, and 1817. His obituary appeared in the Lancaster *Journal* on March 6, 1835, four days after his death, and he was buried in lot 26 beside his first wife, Mary Good, in lot 25. His second wife, Mary Ann, was buried in lot 27 six weeks later.

The tombstone on lot 1 reads: "In Memory of John Patton, born in the County of Antrim, Ireland, who departed this life May 10, 1832 in the 83rd year of his age. He was a soldier in the Revolution, and fought in the battles of Germantown, Princeton, and Yorktown."

Beside him, in lot 2, is Margaret Patton, who died July 25, 1849, aged 84 years 3 months. According to family research²⁰, John and Margaret Patton were married in January, 1785, in Reading, PA. John was 16 years older than his bride, who was also born in Ireland. They had eight children and moved to Lancaster County at the beginning of the 19th century.

Jane Allen, buried in lot 32, was also a native of Ireland, according to her tombstone, and she died October 9, 1826 aged 80 years. Nothing else is known about her, or of Eliza Kain, born April 14, 1807 died May 9, 1868 aged 61 years and 26 days, who now lies in lot $18\frac{1}{2}$,

All the other 43 tombstones with legible inscriptions were descendants, or the spouses of descendants of Isaac Davis (G154) and his wife Lydia Carter.


Condition of the Graveyard

When B.F. Owens visited the Welsh graveyard in the summer of 1896, his article was also printed in the Lancaster New Era on April 17, 1897. The headline read: "The Old Welsh Graveyard in Earl, Where the Early Settlement in the Eastern End of the County Buried Their Dead, A Neglected Spot of Much Local Historical Interest."

On November 18, 1928, an article written by Hon. A.G. Seyfert appeared in a Lancaster newspaper with a picture of the author in the cemetery among weeds taller than he was. The headlines read: "County's First Judge, Revolutionary General, Pioneers Buried in Cemetery Wilderness; Writer Finds Old Welsh Graveyard, Near Intercourse (the article said Terre Hill), One of the Most Neglected Spots in County—Epitaphs on Weatherbeaten Tombstones Reveal Names of Pioneers in County's Early Development Now Buried and Forgotten in Isolated Wilderness of Weeds and Briars".

W.F. Woerner, librarian (1923-1935) of the Lancaster County Historical Society, visited the cemetery on October 12, 1941 and reported: "There was no grass growing in it. Briars and weeds had taken possession of the place. Not all the tombstones were in an upright position; in fact some were lying on the ground while others were broken and the pieces scattered. The stone posts at the entrance in the south wall have also fallen down. There are many field stones still in evidence. There are 43 headstones with inscriptions. There are no trees growing in it. It is regrettable to state that the Old Welsh Graveyard in its present condition presents a picture of decay, abandonment and utter desolation". (See figure 6)

He included a statement in his records²¹ written by Robert E. Simpson on February 1, 1942. "William F. Showalter is the caretaker. He cultivates the land belonging to the graveyard for his services. Since the crops which he is enabled to raise on this small piece of



ground are of little value, the graveyard and walls consequently receive little or no attention. In fact, he is caretaker in name only. Washington Camp, No. 274, Patriotic Order Sons of America, for many years devoted a part of its time and attention to this ancient burial place. The lodge is no longer in existence. The older members of the order who were interested in the graveyard having passed away in recent years, those that remained petitioned the local court to release the lodge from the upkeep of the burial place. The petition was granted."

The graveyard is surrounded at present by land owned by Elton Eby, a grandson of the Enos J. Eby who owned it in 1941. A local Boy Scout troop & Elton Eby cleared most of the brush and briars from the graveyard several years ago, and in the fall of 1983 it was graded and seeded. It is now mowed and trimmed regularly.

A fund has been set up under the auspices of the Lancaster County Historical Society entitled "The Welsh Cemetery Fund". A committee of interested local people has been organized to supervise the fund and to arrange for the reconstruction of the stone wall, which is almost completely fallen down. An effort is being made to work with the Historic Preservation Trust of Lancaster County to insure that the work is done correctly. The following outlines²² of the Morgan, Edwards, and Davis families are included as clues for further research rather than as proof of lineage. Some of the relationships are based, on necessity, on circumstantial evidence. Additions and corrections are invited. Not included are outlines of the other three Davis progenitors, (C) (I), and (S), and the other Thomas Morgan (J), who were complicating the scene. They are a tale for another day.
