# The Gumpf Family of Lancaster Boro Revisited

In the 1984 Winter issue of Kentucky Rifle Association, the late S. E. Dyke wrote of "The Gumpf Family of Gunsmiths of Lancaster Boro, 1787-1875" and of his difficulty in determining the true identity/relationship of nine Gumpfs (sometimes spelled "Gump," "Gumf," "Gomp," "Gompf" or "Kumpf") that he believed were gunsmiths.

In my collaboration with Prof. James B. Whisker in a review of Lancaster County, Pennsylvania, source material relating to that county's numerous gunsmiths<sup>1</sup> for a book on that subject, I have been able to reconstruct much of the Gumpf family genealogy. Records used have been the actual tax records, church records, wills, and estate inventories as well as local biographical annuals and newspapers. Of all those surnamed Gumpf who died in Lancaster County

prior to 1800, only four left wills. For the same period, there are only eighteen recorded deeds in which a Gumpf is a grantor and twelve where a Gumpf is a grantee. Some of these sources were not available to Sam Dyke, thus

making his original attempt fraught with dead ends.


As originally presented in the 1984 article, Sam diagramed two distinct lines of the family, both descended from the original Gumpf settler in the Boro, the stonemason Dietrich (aka Dieder) Gumpf. One line was through his older gunmaking son, Johan Christopher, and included five children: Jacob, Heinrich

(Henry), Matheus, Andrew, and Christoph. The other line was through his second-born son, George Michael, and included three children: Michael, Jacob and John George. My findings are as follows:

Of Dietrich Gumpf's three sons, there were but two that survived childhood: John Christopher and George Michael. With the exception of one individual,

all of the gunsmiths hearing the surname Gumpf are descended from the first

gunsmith of that name, son John Christopher. This includes three of Dietrich's great-grandsons. The one exception is a son of George Michael, Michael. See the diagram below for the relationship of the gunsmiths Gumpf. For what follows, vital statistics are not footnoted because sources are given in the extensive family genealogy presented in the Appendix.



# Dietrich Gumpf (0)

Dyke states that the progenitor of the Gumpf family in Lancaster County was Dietrich (Dieder), who was born in Germany about 1729 and who came to America circa 1740-1750. His arrival has not been confirmed<sup>2</sup> and the earliest

mention of Gumpf is in the Lancaster Borough tax records of 1781. The only time his trade (mason) was included was in 1800, when he was excused from paying tax. The records of the Evangelical Lutheran Church of the Holy Trinity (aka Holy Trinity) record his death in September 1801 at the age of 72 years and 2 months. Since the records are of burials, the exact day of his death

is not given. His burial took place on 24 September and, since burials normally took place within one to three days of death, we can assume that he died around the 21st. Assuming that the age given at death is correct, by interpolation we can place his birth in July 1729. His will was proved October 21, 1801.3 Included in the inventory of his estate held two days previous, in addition

to "I Fowling Piece" valued at one pound and ten shillings, "Sundry Mason Utensills" (five shillings) and other expected items, we are let in on the fact 82

that there was music in the home by the entries indicating two "Clannett" (clarinet?) instruments and a "Violien."<sup>4</sup>

The number of Gumpf's wives has not been verified from the sources

available. The burial record of Anna Margaret Klein refers to her as the widow "Gump." Dyke lists two earlier wives: Margaretta Maintzer and Anna Catherina. In his will, Dietrich left part of his dwelling in the Mussertown section of Lancaster Borough to his wife, Margaret, as long as she might live. Included were the kitchen, the addition, use of the ten plate stove and "its present pipe," part of the garden, and privileges of ground use. Three of his children (Christopher, Michael, and Margaret, the wife of John Lightner) were left the entire Mussertown house. Church records list Catharine as the mother of John Christopher (b.1760), Margaret Susanna as the mother of a daughter of the same name (b.1762), and Anna Catharine Maynzer as the mother of son George Michael (b.1765).

Except for oaths of allegiance, no deeds or other prime source information relating to Dietrich have been found.

### John Christopher (0.1)

The eldest recorded child of Dietrich was born on October 26, 1760. Church records state that his mother was Catharine. Dietrich would have been about thirty years old in 1760 and it is therefore possible that there were earlier born whose names have been lost to history.


Christopher (aka Stophel) made his first appearance in the Borough tax records of 1785 (those of 1784 are missing). His trade, when given, remained "laborer" until 1789 when he was listed as a gunsmith.<sup>5</sup> The 1788 list states that he was living with the whitesmith Abraham Henneberger. He was a contributor of 60 guns to the 1794 General Hand state arms contract.<sup>6</sup>

He married Anna Maria Scheid/Scheib, possibly a daughter of Matthew and Catharine Scheid, in 1786. They had at least eight children, the first born being Jacob. Jacob was also one of five sons who became gunsmiths. In 1843 the family was living on the east side of the second block of North Queen Street. Christopher died on October 6, 1844, at the age of eighty-three. His wife predeceased him by three years. There was no mention of his passing in the city newspapers. No will or estate inventory survive.

### Jacob (0.1.1)

Jacob was born on July 24, 1787. The Borough tax record of 1809 lists him as a freeman gunsmith. In 1812 he married Lydia Getz and fathered at least five children. None followed in his trade. In 1814 the tax list indicates that he was an inmate (renter) of John Gundacker, a local merchant. In 1843 he resided as an inmate in the fourth block of West Orange Street, south side.<sup>8</sup>

He died on June 28, 1847. Although there were nine other Jacob Gumpfs,

this is the only one of that name who is known to have become a gunsmith. No will or estate inventory have been located.

The second son of John Christopher and Anna Maria Scheid/Sheib Gumpf,

### Henry (0.1.2)

Henry, was born on May 4, 1791. His first appearance in the Borough tax records was in 1814 when he was listed as a gunsmith renting from Samuel Humes, a turner. He is not listed as a freeholder (property owner) until 1823. In 1832 it is noted that he sold his lots and once again entered the list as an inmate. The final listing was in 1841, although he does not appear in the 1840 Federal census. The 1843 city directory shows his residence as being


located in the second block of North Queen Street on the eastern side.

In 1813 he married Barbara Hillscher and they had four sons, one of whom, Heinrich, became a gunsmith. No will or estate inventory have been located.


#### Heinrich (0.1.2.1)

Heinrich was the first born of Henry and Barbara Gumpf, that event taking place on January 7, 1813 [sic]. He is listed initially as a freeman with no trade specified in 1833. The next three years he is a freeman gunsmith. Church records indicate that he and Mary (surname not given) had a son Jacob who

was born on April 6, 1836. Heinrich's death is recorded as being in June of the same year.

### **Mathias** (0.1.3)

Mathias was the third consecutive son to follow in his father Christopher's footsteps as a gunsmith. He was born on January 21, 1794, and appeared as a freeman gunsmith in the city tax lists from 1819 through 1825. The lists for the next three years are missing, but in 1829 he is an inmate. He and his wife Elizabeth (family name unknown) had at least four sons and four daughters. None of the sons became gunsmiths. This family lived in the third block of West Orange Street, south side, in 1843. In 1857 the address was West Walnut near Mulberry, in 1859 at Orange at the corner of Mary 12, and then in 1863 they were located at 42 North Water Street. His wife predeceased him in 1845.

#### Johan George (0.1.5)

Maintaining the family tradition, Johan George, born June 20, 1800, also became a gunsmith. A freeman from 1823 through 1825, he had become an inmate by 1829. Church records indicate that his wife was Mary McGlinn. They had six children, one of whom was a son who appears to have become a blacksmith.<sup>14</sup>

#### Andrew (0.1.6)

It would appear that John Christopher Gumpf had a dynasty of gunsmiths in mind since five sons in a row took up the same trade. Andrew (born April 14, 1802) not only became a gunsmith, but he saw to it that two of his sons did also. His first wife was Margaret Kuntz/Kuhns, who bore at least six of his nine children. In 1844 he married Margaret Roth, who according to the 1850 and 1860 Federal Census was born circa 1804. In 1843 they resided on North Queen Street on the east side of the second block.<sup>15</sup>

The city tax lists of 1826-1828 are missing and we do not see Andrew make his first appearance until 1829, when he is a freeman gunsmith. The following year he is an inmate gunsmith. The 1850 census of manufacturers shows that Andrew had a capital investment of \$600. During the previous twelve months he had purchased 70 gun barrels for \$124, 70 gunstocks for \$80, 70 gunlocks at \$68, 70 sets of mountings for \$35, and 50 bushels of coal for \$10. When completed, the 70 guns were valued at \$840. Other gun work was valued at \$200. The average number employed was two and the average monthly wage was \$50.16 He was the only Lancaster City gunsmith included.

Andrew died sometime between the Federal Census of 1850 and the publishing of the 1857 Lancaster City directory. The 1863-64 city directory indicates that his widow was living at Lemon near Water Street.<sup>17</sup>

# Emanuel (0.1.6.1)

Andrew's first child was born on July 20, 1826, and he was named Emanuel. The 1850 Federal Census states that he, too, was a gunsmith by trade. The City tax records of 1852 merely call him a "smith." The 1863-64 city directory lists him as a clerk living on West Orange at the corner of Queen Street. Further details about him have not been developed.

# Andrew Jackson (0.1.6.5)

1860 and 1900 he is listed as a gunsmith. The 1900 Census lists him as a head of household residing with spinster sisters Mary and Catharine at 319 W. James Street. Since the census records him as single, it implies that he never married. In the 1905-06 city directory his shop was located at 29 North Prince Street. Street.

The inventory of his estate taken on November 23, 1907,21 is the only

Andrew's next son was born circa 1838 and in the Federal Census of both

known inventory of a Gumpf gunsmith. It contains: lot of carving tools, ram rods and wire, steel rods, files, \$5.50; square, 9 pistols & gun, 2 hack saws, lathe & drills, oil stove, \$15.00; 4 boxes sundries, caps and drills, "vice" and bench, scroll saw, \$6.50; lot chisels, pliers, screw drivers, hand "vices," 4 braces, \$5.00; whet stones, hammers, soldering irons, planes, hatchet, &c., \$3.00; 2 anvils, "vice," sundry parts of guns, forge, chair, grind-stone, \$7.45; oil cans, lot of old guns, 2 saws, some good guns, shelving, \$10.50; lot of gun supplies, oils, gun stocks, old pistols, gun barrels, \$9.00; 2 homemade

guns, \$35.00; money in pockets, \$75.00. Total: \$175.45.

Andrew Jackson Gumpf appears to have been the last of the gunsmiths Gumpf.

# Christopher (0.1.7)

There is evidence, although questionable, that John Christopher Gumpf's sixth son also trained as a gunsmith although he spent his career as a shoemaker/bootmaker. If the evidence is valid, then all of John Christopher's six sons were gunsmiths in addition to two of his grandsons. The evidence is the first entry in the tax lists for son Christopher in 1829: it reads freeman gunsmith. It has been pointed out above that the 1826-1828 tax records of the city have been lost. Having been born on September 17, 1805, Christopher would have

been expected to make his initial appearance in the 1828 list. The loss of this list removes the extra evidence necessary to confirm that he started off as a gunsmith. In 1831 his trade is given as shoemaker, which persists through the last year examined, 1852, with two exceptions: in 1832 the trade was initally given as "gun" but then a line has been drawn through the word and "shoemaker" substituted.

The final exception is found in the list for 1835 when gunsmith is given. This is all very interesting, but in the days of apprenticeship training lasting fourteen years, it is unlikely that someone would have trained in two trades,

and that these entries indicating the trade of gunsmith are merely errors on the part of the tax assessor.

Christopher married Margaret Susan Brown/Braun in 1886 and they had at least two children. It is unknown if son William Henry, also a bootmaker, ever tried his hand at gunsmithing. Christopher Gumpf died in 1884.

#### Michael (0.3.1)

This is the only Michael Gumpf to be identified in the tax records as a gunsmith. He was born on October 23, 1786, the first child of George Michael and Margaret Gumpf. He appears in those records for one year, 1808, as a freeman

with the notation "gone" next to his name.

apparently collocated with the Gumpf gunsmiths Christopher, Henry, and Andrew has not been satisfactorily explained. It may be this Michael returned to Lancaster. His father, George Michael, appeared in the city tax records from 1788 (age 23) through 1829 as a laborer, millwright, "lame," peddler, and, from 1830 through 1838 as a billiard keeper. The last four years of his life he had no trade specified. In his will, proved September 29, 1843, he gives no trade and describes himself as "lame through accident." This accident apparently took place around 1801 as the tax record of that year has the notation

# Comments

"wounded by a shot."

Having conducted extensive research into the genealogy of various early

Lancaster City families, the following comments are offered.

Members of the Gumpf family apparently were little involved in the matters of their local government, civic activities, or their church. Only six members of the family are mentioned in the major local history,<sup>23</sup> and three of them

appear only because of service as privates during the Civil War. In no instance are they associated with a fire company, a charity, an elected office, or other similar position. No portrait has been found of any of them. As pointed out in the beginning of this article, only a handful of recorded deeds and four wills involve them prior to 1900. As observed in the material about John Christopher, even their passing often went unnoticed in the local press. Regardless.

Regardless, like so many of these early important families of Lancaster, the surname no longer survives within the county telephone book at this time. Their names only survive in their extant artifact creations.
