Assessments in 1773 were: Provincial total 3575-£, 10-s, 6-d, and County Tax Tax 672-£, 11s, 7-d.

Note: It is rather surprising to know that in those times the people paid six times as much state or rather provincial tax and they paid county tax.

The relative importance, financially, of the various townships and of the Boro of Lancaster also may cause surprise. The value of Earl Township, was just about the same as that of Lancaster Boro. Next to Earl Township our wealthiest townships in their order were Cocalico, Leacock, Lampeter, Salsbury, Strasburg and Warwick, etc.

## (c) FAVORITE HOTELS AND LODGINGS IN LANCASTER IN 1799 (LODGINGS OF ASSEMBLYMEN)

Among the Lancaster County Miscellaneous Documents in the Volume of Manuscripts from 1774, etc., p. 139 appears a statement of the addresses in Lancaster of the Members of Assembly of 1799. This shows the popular hotels and other houses of entertainment, lodging, etc., particularly as the officials of the State viewed it. By Counties, etc., the list is given as follows:

Isaac Weaver, the speaker, lodged at George Fifer's Inn.

The Philadelphia City delegation all lodged at the same place, at Mrs. Trissler's on Donegal Street. They were: Michael Keppellee, Sam. W. Fisher, William Hall, Godfrey Hagen, Geo. Fox and Robt. Frazer. The Philadelphia County delegation divided. Thomas Mifflin and Warral

The Philadelphia County delegation divided. Thomas Mifflin and Warral Eyre were at John Bausman's on Queen Street and so also was William Penrose; William Leonard, Geo. Ingels, Geo. Logan and John Roberts at George Nauman's on East Orange Street. Bucks Countians lodged as follows: Isaac Van Horne at Nauman's and Ralph Stone and James Erwin at John Musser's corner of East Orange and Lime Streets and Gerardus Wynkoch at Judge Henry's.

The Chester County legislators divided: Jos. Hemphill lodged at A. Scott's on Orange Street; Jas. Hannum at Ferree's on King Street Thos. Bull, Roger Kirk and Abiah Taylor at Peter Hoffnagle's on S. Queen Street.

The Lancaster County assemblymen lodgings: Jacob Strickler and Richard Keys at Mr. Barton's; Alex. Scott on East Orange Street; Daniel Buckley at Peter Hoffnagle's, and Jeremiah Brown and John Hopkins at the Black Horse North Queen Street.

The York County delegation lodged at Col. Francis Johnston's, but the location is not given. Thos. Campbell, Alex. Coheal, Alex. Turner and Wm. McPherson so lodged; and Yost Herbach and Jacob Hostetter lodged at Peter Byers' on King Street.

Of the Cumberland County assemblymen Jacob Alter and Daniel Mitchel lodged at Sam. Clendening's on N. Queen Street, and Robt. Whitehole at David Hall's on North Queen Street.

Of the Berks County assemblymen Charles Shoemaker and Peter Fraily lodged at John Bausman's, and Daniel Rose, Wm.. Whitman and Daniel Udree lodged at Peter Gonter's on N. Queen Street.

The Northampton and Wayne Countians lodged at Peter Gonter's, that is John Coolborough, Wm. Barnett and James Wilson did; and Jonas Hartzell lodged at Mr. Bausman's on N. Queen Street.

Hugh Barcley and Chas. Stewart the Bedford County assemblymen lodged at Mr. Rine's on Queen Street.

Jacob Folmer of Northumberland lodged at Henry Slaymaker's Spread Eagle Tavern on E. King Street, and Simon Snyder his only associate lodged at Peter Gonter's.

The Westmoreland County men lodged at George Fisher's that is Jacob Powler and Michael Pugh did and Geo. Smith at Mr. Baily's on West King Street.

The Washington County delegation all lodged at Baily's. They were Aaron Lyle, John McDowell and Sam. Urie.

John Conyngham of Fayette County lodged at John Messemcop's on King Street and Pressly Car at Lane's. No location is given.

Daniel Royer, John Scott and Andrew Dunlap the Franklin County assemblymen all lodged at Mr. Rine's on King Street.

Of the four Montgomery assemblymen, Fred. Conrad and Isaiah David lodged at John Bausman's on N. Queen Street, and Nathaniel Boilieu at David Hall's on N. Queen Street, while Jonathan Roberts lodged at John Robert's on Orange Street.

The Dauphin County men scattered. James Wilson lodged at John Gonter's on N. Queen Street, Christian Levy at John Bausman's and Stacy Potts at John Robert's on Orange Street.

John Franklin the Luzerne County man lodged at Eliz. Pry's on King Street.

John Blair of Huntingdon County lodged at Peter Hoffnagle's.

The two assemblymen from Allegheny lodged at Weaver's Tavern. They were James Sample and Dunning McNair.

The Mifflin County assemblymen lodged at Slaymaker's Spread Eagle Hotel. They were James Harris and William Beale.

The Delaware County assemblymen stopped at John Musser's. They were Jonas Preston and Moses Palmer.

Adam Miller of Somerset County lodged at Peter Byer's on King Street, and John M. Hunter of Lycoming Co., at Adam Weaver's on N. Queen Street.

Jas. Bullock the Clerk of the House lodged with the Treasurer; Jas. Webb the assistant clerk at Weaver's; the Sargent at Arms at James Alexander's, and the Door Keeper on Orange Street.
